Code C para. 10.5 The caution shall be in the following terms:-You do not have to say anything. But it may harm your defence if you do not mention when questioned something which you later rely on in court. Anything you do say may be given in evidence.

A police officer can only arrest if one of the following conditions applies Investigation - the investigation of the offence (or conduct of the person) needs to be prompt and effective.

Disappearance - the disappearance of the person (if not arrested) will hinder the

prosecution.

Child—to protect a child or other vulnerable person from the person in question.

Obstruction—to prevent the person causing an unlawful obstruction of the

Physical harm - to prevent physical harm being caused to any person.

Public decency - to prevent the person committing an offence against public decency (but only if members of the public cannot be reasonably expected to avoid that person).

Avoid that person.

Loss or damage – to prevent the person from causing loss or damage to property.

Address – the address of the person has not been provided or cannot be ascertained or there are reasonable grounds to doubt the address given.

Name – the name of the person has not been provided or cannot be ascertained or there are reasonable grounds to doubt the name given.

The mnemonic ID COP PLAN summerises the above points.

When completing your own or any other witness statement take account of the guidance offered in the $R\ v\ Turnbull$ ruling. The following points should be

- A amount of time under observation.
- D distance from suspect.
- V visibility.
- O obstructions to the view of the witness.
- K known or seen before (when and where).
- A any special reason for remembering suspect.
- T time lapse: how long has elapsed since the witness saw the suspect.
- E error or material discrepancy between the description given in the first and subsequent accounts by the witness.
